**SENATE ACT 20-19**

**TO APPROPRIATE FUNDING FOR LEARNING ASSISTANCE CENTER’S “FOOD FOR THOUGHT”**

BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:

**SECTION I. PURPOSE**

The Learning Assistance Center is a program under the Office of Undergraduate Education at UH Manoa that provides free tutoring and academic support for all UHM students. In preparation for Final Exams, every semester, the LAC hosts walk-in tutoring in Sinclair Library during the week of finals and the previous week, which helps provide equal opportunities for all students to receive academic support. In response to a recent demand for snacks and refreshments by students, the LAC would like to implement “Food for Thought”, in order to fulfill such requests. “Food for Thought” would be providing light snacks and refreshments, free of cost, to all UHM students participating in LAC tutoring during the two-week period.

**SECTION II. APPROPRIATIONS**

A total of \$400.00 shall be appropriated from Senate Account #3325232 (University Programs, Services and Support).

**SECTION IV.** Any unexpended and unencumbered balance of any appropriation of this Act, as of the close of business on May 1, 2019 shall lapse into Senate Account #3325232.

**SECTION V.** The Treasurer is authorized to draw upon said account.

**SECTION IV.** This act shall take effect upon approval by the Senate.
