SENATE ACT 08-25

**TO ALLOCATE FUNDING FOR A SERIES OF EDUCATIONAL PANELS AND LECTURES
PERTAINING TO DECOLONIZATION**

BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:

SECTION I. PURPOSE

To allocate funding for educational events during Decolonial November, which seeks to spread awareness about decolonization in a variety of disciplines and offer diverse perspectives on the matter. There will be a total of four panels. They will be made of undergraduate and graduate students and of faculty and community members; focusing on decolonizing science, decolonizing wai, and on decolonizing efforts in other parts of the world that share commonalities with Hawai'i nei.

SECTION II. APPROPRIATIONS

A total of \$10,249.04 shall be appropriated from Senate Account#3325232 (University Programs, Services and Support) sections C2 and C4, 50% from each respectively.

SECTION III. PROVISIONS

The ASUH Finance and Campus Life Committee shall gather necessary paperwork ASUH shall be recognized as a sponsor of these events. All funding is pending approval of the ASUH budget by the OVPSS.

SECTION IV. Any unexpended and unencumbered balance of any appropriation of this Act, as of the close of the business period December 13th, shall lapse into Senate Account #3325232. Specifically Section C2 and Section C4; 50% from each respectively.

SECTION V. The Treasurer is authorized to draw upon said account.

SECTION IV. This act shall take effect upon approval by the Senate.
