Senator Rafid Move to accept Standing Committee Report 05-20 Regarding Senate Revision 04-20

from the Committee on Internal Affairs.

Vice President Chun Second.

Chairperson Manabe This SCR clarifies leave requests, especially summer leave requests, and condense

the proposed revision of Rule 19-4, the part about summer leave request and summer

cash awards. This also clarifies wording proposed in the revision.

Vote was unanimously in favor; Motion carries.

SCR 05-20 was approved.

READING AND APPROVAL OF THE MEASURE

Vice President Chun Move to accept Senate Revision 04-20: Relating to Leave Requests.

Senator Rafid Second.

SAL Manabe In our rules, there is a paragraph that explains what taking a leave is, and stipulations

regarding your Award for Service if you are on leave. What this rule revision is about is to explain more about what leave is, provide reasons for taking a leave, explain quorum in reference to those on-leave, how long someone can be on-leave during the summer and during the semester. Things that the Internal Affairs

committee added was a summer leave request period, how someone can receive an Award for Service while on-leave through an appeals process, and how the appeals

can be approved or not.

Interim Secretary Dela Cruz visually applied the amendments approved on the SCR

05-20 onto Senate Revision 04-20.

Vice President Chun When you changed the language for appealing for an Award for Service, what made

the change to specifically to receive a month of award?

SAL Manabe This came from a question from Senator Juliano about what happens if a Senator

took leave for a small time out of a month, and did ASUH work throughout the whole month even during the leave, but only received a pro-rated award for taking leave. If the Senator did work during that time as well, could a Senator appeal to have the full month's award? This rule revision allows for opportunities like this, provided that Senators provide documentation that they did some work, and that the

Executive Committee approved of this.

President Li This is only relating to summer leave, so that if you were on-leave for a certain

amount of time, you can appeal up to 1-month's worth of time that you were on-leave to receive an Award for Service for that period. If you were on-leave for 1 week during a month, but you were Awarded for the rest of that month, you could appeal to receive an Award for the 1 week you were on-leave. This leaves you with 3 more weeks during the entire summer that you can appeal for. The total time you can appeal in the Summer is 1 month, IF you are appealing to be compensated for

time that you were "on-leave." While this rule revision clarifies "on-leave" it also creates an appeal process for those on-leave.

Vice President Chun

I'm just a little confused, for example, Senator Juliano said she was on leave for 1 week. If she didn't do her duties during that time, would her Award for that month decrease? Or would she not receive her Award for Service at all?

SAL Manabe

She would receive a pro-rated award for that month, as stipulated based on our current rules. However, with this rule revision, she could appeal to be awarded for the week she was on-leave so that she could get her full month's award.

iSecretary Dela Cruz

This Senate Revision is confusing in the way that it is structured. The rule revision is mainly about Summer leave, but the overarching rule that this revision is on is 19-4(i) which is pertaining to all on-leave requests. There is no language in line 19-4(i) that says it is for summer only. So I think maybe we need to clarify that it is only for Summer, so that all the proposed language following this rule only pertains to summer leave.

SAL Manabe

The "summer" language is only under (5), everything else is relating to what "on-leave" is. We also put in section (5) that explains more about summer. But Section 5 does not have the word Summer. The SCR removes "summer." If you were on-leave during the semester, would the appeal process apply to those on-leave during the year?

iSecretary Dela Cruz Senator Bowersmith

I don't think we have an appeals process for those on-leave during the year. Senators

President Li

are also permitted up to 1-month on-leave during the semester. So my question would be, would the 4 weeks you can appeal for being only for summer? Or if we did have an appeals process for during the school year, could we

Senator Bowersmith

have additional 4 weeks to appeal for during the year?

SAL Manabe

We only decided to do Summer because besides doing ASUH work, you're responsible for coming to meetings. For the summer, you have Senators who are on leave for like 3 months. They can't do the portion of physically attending meetings. So the 1 month, allows Senators to be awarded up to 1-month's worth of an Award for Service for the work that can do for ASUH since they can't physically be here. When these rules were created, the assumption is when you are "on-leave" you

wouldn't expect to get any type of Award for Service. And if you wanted to have an Award for Service, you wouldn't ask to formally be on-leave. I apologize because I didn't go to any of your meetings. If you don't go to the committee meetings, a lot of the discussion is hashed out here at the General. The other thing is that if people are on-leave, having something that says you're on-leave but you wanted to get an Award for Service, that this is the criteria that you need to follow to be eligible for your award. This is so it's more of a positive way than to deal with things backward to appeal. It's like having the criteria to receive your Award for Service, and IF you are on-leave, here is a different criteria that you need to deliver to be eligible. Instead of going backwards and having them to appeal something that they were denied. This is historically why we do not have an appeals process for those who were on-leave.

Senator Bowersmith

Trying to set a precedent for appeals like that could be difficult, and it would be easier to set qualifications for Senators to meet to receive their Award. I think that might be easier.

iSecretary Dela Cruz

Echoing what Advisor Manini and Senator Bowersmith is saying. We should work towards a way where we set up our rules so that Senators are in a position where they can practice in favor of our rules, like following a criteria, rather than going through the binary system of submitting complaints or appeals against our rules. Perhaps Senators should amend their on-leave requests, or no request to be on-leave if they want to receive their Award for Service. Rather than changing our rules.

Vice President Chun I don't think it would be possible since a lot of our Senators are on-leave, and they

would not be able to fulfill half of their responsibility to attend meetings.

SAL Manabe Section 5 has some type of guidelines to get their Award for Service up to a month.

Senator Balico I move to refer Senate Revision 04-20 Relating to Leave Requests to the Committee

on Internal Affairs.

iSecretary Dela Cruz Second.

Senator Rafid Why are we sending it back?

SAL Manabe People don't understand the revision. If you have any concerns or questions about

revisions, you can always come to the committee meetings so that we don't have to

have longer conversations during General.

Senator Rafid If we send it back, it will be the same thing.

Advisor Manini This is not one of those simple rules that provide guidelines. It actually creates

bureaucratic process. So when you guys do that, you want to have the most efficient process in place, so that it doesn't create more problems in the long run. I totally hear these two, I don't want to sit in the meeting for hours, but at the same time, you guys should want to have the best process possible so you don't have to deal with

bureaucracy throughout the year.

Senator Bowersmith The only thing I want to add is that I had an experience with appeals processes, and

people try to bring stuff to you to ask you for something. The more specific we can create guidelines for, the easier it is to make a decision. So I feel like as long as

guidelines are specific, it will be easier in the future.

iSecretary Dela Cruz The reason that I am comfortable with sending this revision back to Internal Affairs

is that I believe this rule revision touches upon two things that should be separately explained, which is "on-leave" and appeals process for Award for Service. I had previously sent a potential rule revision draft to Chair Manabe and Advisor Manini which include my ideas that touch upon how we can organize and further explain an Awards for Service appeals process and include SAL Manabe's On-leave rule

revision. I'm not sure if you guys had the time to look at it.

The Senate concluded that they could not make the substantial revisions to the Rule Revision to address the present issue of having the revision implemented versus setting up guidelines. The idea of creating guidelines to receive an Award for Service while on leave was presented and given feedback, but could not be further implemented at the time of this discussion as the specific language was not written out. The Senate felt they needed to dedicate the time to discuss this language. Some consensus was verbalized to officially refer the revision back to the committee.

Vote was in favor; Motion carries.

Senate Revision 04-20 was referred back to the Committee on Internal Affairs.
