**SENATE ACT 15-20
FUNDING FOR AN ESPORTS SPACE CAMPUS SURVEY**

BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:

SECTION I. PURPOSE

As esports is an emerging scene on college campuses, ASUH finds it necessary to gather student input on whether the campus should create a space for competitive and recreational esports. This survey will gather student opinion on the establishment of an esports space on campus for both competitive teams and recreational players. Results from the survey will show student input on where the space should be located, if students are interested in a space, and how will students utilize an esports room on campus. ASUH will use survey data to communicate with other departments and campus organizations regarding the space.

To gather student input, funds appropriated in this bill will go to Information Technology Services (ITS) on the UH Mānoa campus. ITS will administer the survey through its services and distribute the questions to students through MyUH.

To promote the survey and encourage students to participate, all students who complete the survey will be eligible for a drawing to win various prizes, which may include a gaming keyboard or mouse, a gaming headset, and gift cards. All students who completed the survey prior to closing will be chosen through random selection.

SECTION II. APPROPRIATIONS

A total of \$550.00_ shall be appropriated from Senate Account #3325232 (University Programs, Services and Support).

SECTION III. PROVISIONS

The Student Affairs Committee will be in charge of administering the survey. Questions to appear on the survey will be provided by the UH Mānoa esports teams with ASUH consultation and feedback.

SECTION IV. Any unexpended and unencumbered balance of any appropriation of this Act, as of the close of business on May 6, 2020 shall lapse into Senate Account #3325232.

SECTION V. The Treasurer is authorized to draw upon said account.

SECTION IV. This act shall take effect upon approval by the Senate.
