SAL Manabe	The reason why we have these is because there are committees that review and discuss things that are confidentials whereas committees that discuss things that can be reported to the General Senate.

Senator Transfiguracion Move to accept Senate Revision 02-20: Relating to Internal Affairs.

READING AND APPROVAL OF THE MEASURE

Vice President Chun	Second.
SAL Manabe	Campus Delegates are our eyes and ears on campus as they serve on different campus-wide committees. The Senate would like to know more about what goes on in these committees. This revision outlines responsibilities of the campus delegates, so that they know what is expected of them and understand how to retain their position. This revision also allows the IA committee to provide awards for service to our delegates, stipulates what kind of information can and cannot be shared with the Senate, and establishes procedures regarding the membership and responsibilities of our delegates.
iSecretary Dela Cruz	I feel that this new rule addition could be made as rule of its own. It could a new rule called "Rule # Campus Delegates." Since this proposed rule revision outlines details of responsibilities regarding a position, it could best placed somewhere in our rules, such as under PART III since PART III outlines the duties of our ASUH positions too. Or some other part of the Senate Rules that fit best. My reasoning for this is that the purpose of Rule 18 and all rules under PART V: COMMITTEES outlines the structure of ASUH and its purposes. We should refrain from amending PART V unless the purpose is to restructure ASUH.
iSecretary Dela Cruz	I would like to recommend to the Senate that we remove any language in this Senate Revision that indicates where this rule revision will be placed in our Senate Rules. That way, we can leave it up to the <i>Revisor of Rules</i> to determine where this new rule can be placed. Just as so long that we do not permanently amend Rule 18. <i>Questions and discussion about understanding the reasoning to make the changes</i> <i>that iSecretary Dela Cruz suggested took place.</i>
SAL Manabe	I move to strike "Rule 18 <i>Other Committees and Duties</i> " under Section II and put "Rule X <i>Campus Delegates.</i> "
Senator Juliano	Second.

SAL Manabe	I move to strike all language from "18-1" to "18-5(b)" except for subsections "(i)" through "(vii)" under "18-1(e)(1)." We're still gonna keep the underlined part of the revision, but just striking Rule 18. It doesn't mean that everything is gone.

President Li	This means that it's entirely new rule revision and rule. Rule 18 will not be affected, but the same language introduced for approval will be added as a new rule once approved.

However, this resolution supports the latest tution proposal now that it has been approved by the Board of Regents (BOR).

iSecretary Dela Cruz	It is the responsibility of the introducers of resolutions to send out the codified resolution. If you need the resolution before the deadline of codification, please speak with me so that we can get your resolution ready to send out as soon as possible.
President Li	I like that this resolution states that although we support the tuition freeze, we also express that we do not want students and anything related to students be affected by the change in tuition costs, and that we support other ways that help fund our University. With a tuition freeze, where else will we get our money from? What I really like about this resolution is that it states that even with a tuition freeze, we do not want budget cuts from student programs and support. Resolutions have nuances like these that are important rather than a blanket statement that generally supports the freeze.
