#### BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:

#### SECTION I. PURPOSE

The purpose of this bill is to appropriate funding for the Perception and Attention Research (PAR) Lab within the Department of Psychology for their seminar event. The mission of this lab is to provide the entire student body with knowledge and research experience in the field of psychological science and also to create insight and appreciation of brain research in non-majors and the community.

The proposed seminar will consist of an introductory lecture led by the lab director, a magic show performance by Mark Mitton to exemplify limitation of cognitive process (i.e., illusions that will exploit limitation of our attention), and close with a panel discussion. The seminar will be open to the entire student body, University of Hawaii system and community members).

#### SECTION II. <u>APPROPRIATIONS</u>

A total of \$5000.00 shall be appropriated from Senate Account #3325232 (University Programs, Services and Support).

ASUH shall be recognized as a sponsor of this event/project.

All lodging must be reimbursement only.

SECTION IV. Any unexpended and unencumbered balance of any appropriation of this Act, as of the close of business on May 6, 2020 shall lapse into Senate Account #3325232.
