# A BILL FOR AN ACT FUNDING FOR THE SPRING 2020 RIO FUNDING PROCESS

### BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:

### SECTION I. PURPOSE

The ASUH Finance Committee is tasked with facilitating the ASUH RIO Funding for the Spring 2020 Semester. The entire process details updating forms, processing applications, advertising the funding, holding informational sessions, conducting interviews for all the RIOs interested in applying, and more. The purpose of this bill is to aid the Finance Committee in executing the RIO Funding Process through funding venue rental, and food & food supplies.

ASUH RIO Funding Interviews for the Spring 2020 Semester will be conducted over a three-day period on Friday, February 21st, Saturday, February 22nd, and Sunday, February 23rd. The interviews will be held in Campus Center rooms, which are under the jurisdiction of Campus Center Meeting & Events Services who charge a room rental fee for operating during non-operational hours such as on Sunday. The interview period will take place from 10:00 am - 6:00 pm, requiring an eight-hour room rental. The hourly rate for renting the room is \$115.00/hr, however, due to ASUH's status as a CSO a 25% discount on the cost will be applied.

The interviews will take place over an extensive period of time over the days mentioned earlier. An amount of \$150.00 for food & food supplies has been requested to ensure senators participating in the lengthy interview process are performing at their best with little distractions
